Minimum deposit is \$100.00 per kitten (American Shorthair, pet) \$200.00 (American Shorthair, breeder/show). If paying for the kitten in full, mark your balance as zero. There is no charge for the upkeep of the kitten until the appropriate age for shipping (12 weeks) or if a payment arrangement is in effect. After 90 days, kittens are boarded at \$5.00 per day until shipped unless weather prohibits shipping or another arrangement has been made. Additionally, if we do not hear from you for a period of ninety (90) consecutive days the sale is considered void and no deposits are refundable.

All shots and worming are age appropriate at the time of shipping or delivery. TICA papers but **not** vet check, health certificate (domestic shipments), shipping crate (if shipped) and flight charge are included in the price of the kitten. The kitten will not be shipped until payment in full including shipping costs in negotiable funds, i.e. Cashiers Check, MO or personal check (with ten days clearance time) is received. PayPal can be used but 5% of total costs will be added so that PayPal charges are paid.

If purchasing a "Pet" kitten, the Blue Slip required for registration with TICA will be withheld until proof of spaying/neutering is received. We cannot be held responsible for Blue Slips held over six months from the date of shipping. Blue Slips for "Breeder" and altered kittens/cats will be sent with the shipment or as soon as received from TICA.

You must agree to never allow your kitten/cat to run loose outside where threats from autos, wildlife and disease can cause harm to it. You agree to provide high quality food (Science Diet, Pro-Plan for Kittens, etc), routine vaccinations and medical care as required to maintain the health and vigor of this animal throughout its' life.

## Purchase/Reservation Agreement: Kitten

Kittens are guaranteed healthy when they leave us. Kittens should not be around other animals and should be handled gently until examined by your vet and found to be in good health with no contagious diseases. We will replace your kitten with another kitten of equal value when available if you bring your kitten to your vet within 48 hours of purchase and he/she deems there is a life threatening disease and we are notified in this time frame. If this should occur, we must be notified immediately and the cat in question needs to be sent back to us at your expense. We will then take the cat to our Vet and if the diagnosis is the same we will replace with kitten of equal value if available within a year . Remember, kitten/cat must be vet checked by your vet and at your expense, within 48 hours after they leave us for this clause to be in effect, otherwise there will be no compensation given.

- You further agree that **BAYOUASH CATTERY** is to be held harmless for any damage, injury, death, financial loss or consequential damages caused by your possession of any feline regardless of species. It is also noted that pregnant women should not clean or handle litter boxes in order to protect their unborn child from the danger of toxoplasmosis. In the unlikely event of a dispute, LaSalle Parish, LA has venue.
- **This transaction will not be valid until this form is returned, completed in full and signed. Please make a copy of this document for your records, sign original, and return to me.**
- **Please complete any information missing at the top of this form; also please make all checks, money orders, cashier's checks payable to Margaret Mello and not the cattery.**
